All the Head of Offices were requested vide this Office letter No.Estt -M-1701/5/2022-Admin-Min.Estt-6980 dated 21.11.2023 to expedite applications for compassionate appointment and they were requested to complete the required information from concerned candidates In Annexure - I and sent to this office duly verified and signed on or before 30. 11.2023. But, information in Annexure-I **with proper enclosers** in respect of none of the candidate is received in this office through concerned office.

It is observed that they have not yet furnished essential information as on 01.01.2023 i.e. details of family pension, monthly income certificate, value of movable/immovable property, number of dependents, number of unmarried daughters, number of minor children, NoC from dependent family member in favour of the candidate

(if son or daughter is candidate) and affidavit from candidate for taking care of family members. In want of these information, the Meeting of the Screening Committee could not be held for consideration of their candidature, so far. The delay in submission will cause delay in consideration of the name of candidates.

It may be noted that if any candidate has not sent Annexure-I dully filled and signed by him/her to the concerned office and not found in this office within a period of 15 days from the date of issue of this letter, his/her candidature for considering his/her name for compassionate appointment for the Vacancy Year 2023 will not be considered by this office and he/she will be solely responsible for the same.
