They are advised to give their acceptance or otherwise within 10 days from the date of receipt of order and report for duty at their place of posting on promotion within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

They may give option within one month from the date of taking over the charge of the post, whether they will get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP their pay will not be fixed. However, in the event of differences in pay the difference may be allowed as per rules.

Promotion order in respect of above official is subject to further orders which may be passed by the Hon'ble Supreme Court as per DoP& T OM No. 36012/11/2016-Estt.(Res-i) (Pt-II) dated 15.06.2018.
