On the recommendation of the DPC (Group-B), (Non-Gazetted) and with the approval of the Competent Authority, Sh. Upen Singha, Staff Car Driver (Grade-I) is hereby promoted to the post of Staff Car Driver (Special Grade) (Group-B, Non-Gazetted) in Level-6 in the Pay Matrix with his present place of posting at CGWB, Div-VII, Guwahati. His promotion will take effect from the actual date of his joining to the promotional post.

Since, there is no change in his place of posting, he is not entitled for TA/DA & joining time as per rules.

He is advised to give his acceptance or otherwise within 10 days from the date of receipt of order and report for duty at the place of posting within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and his promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

He may exercise option within one month from the date of taking over the charge of the post, whether he will get the pay fixed in the new post either straightaway from the date of joining on promotion to the new post or from the date of his next increment in the old scale. In case he has already been granted financial up-gradation under MACP scheme his pay will not be fixed. However, the difference of grade pay will be granted to him as per rule.

In case of failure to report for duty on promotion, he will be debarred for promotion for a period of one year in terms of Ministry of Home Affairs, OM No. 22034/3/81-Estt(D) dated 01.10.81.
