In pursuance to the Ministry of Jal Shakti, Department of WR, RD & GR letter No A-50/3/2022-GW Estt dated 11<sup>th</sup> February, 2025 and in terms of the provisions contained in Department of Personnel & Training O.M. No. 35034/3/2008 Estt.(D) dated 19.05.2009 ,O.M. No. AB-14017/37/2008-Estt.(RR) dated 10.09.2010 & O.M. No. 35034/3/2015-Estt (D) dated 22.10.2019 and on the basis of recommendations of the Departmental Screening Committee, the approval of the Competent Authority is hereby conveyed for grant of 3<sup>rd</sup> financial up-gradation in Level-13 of pay matrix as per 7<sup>th</sup> CPC under Modified Assured Career Progression (MACP) Scheme to the following Scientists 'D' of Central Ground Water Board w.e.f. dates mentioned against their names subject to the conditions laid down in the DoPT's above stated O.Ms-

2. The financial up-gradation shall be purely personal to the employee and shall have no relevance to his/her seniority position. However, financial and certain other benefits, which are linked to the pay drawn by the Officers, shall be permitted.

3. With regard to fixation of pay on grant of financial upgradation under the MACPS, the officer has an option under FR 22(1)(a)(1) to get his/her pay fixed in the higher grade pay either from the date of his/her financial upgradation or from the date of his/her next increment.

4. Grant of higher pay scale under the MACPS shall be conditional to the fact that when financial up-gradation has been allowed and the officer subsequently refuses the promotion, it shall not be a ground to withdraw the financial upgradation.

5. On making fixation of pay, the officer concerned is advised to submit an undertaking to the effect that arrears of pay on account of granting financial up-gradation under the MACPS will be subject to any audit objection etc. and he/she will refund the amount drawn by him/her as excess pay and allowances by virtue of higher pay scale in lump sum, in case it is found that the same is not applicable in his/her case.

6. While issuing pay fixation orders, a Para may be added to the effect that the above fixation of pay in the upgraded scale is subject to review by audit. Any over payment on account of pay fixation in the upgraded scale as pointed out by the audit will be recovered from him/her in lump-sum.
