Sir,

Please refer to CHQ's previous letters of even dated 09.11.2020, 01.02.2021, 15.06.2021, 29.06.2021, 28.07.2021, 03.08.2021, 04.08.2021, 02.09.2021 and 09.09.2021 (uploaded on CGWB's website) on the subject cited above. In this connection, it is to inform that in order to process compassionate appointment for the Year 2019, 2020 and 2021 (upto 7/2021), all the Head of Offices were requested vide above letters to get complete details of family pension, monthly income, value of movable/immovable property, number of dependents, number of unmarried daughter and number of minor children as on 01.01.2019, 01.01.2020 and 01.01.2021 from the candidates for compassionate appointment in Annexure – 1 and send to this office within a month.

But, it is observed that in spite of repeated letters/reminders and telephonic discussions, many times, the above field offices could not get completed and sent Ann. 1 from the candidates mentioned in enclosed List. This has been seriously viewed by Chairman, CGWB and Ministry. Three letters have also been sent to the candidates mentioned in the enclosed List by Speed Post to submit information in Annexure – 1 with relevant documents to the concerned Head of Offices. But, they have also not submitted so far.


Therefore, above Heads of offices are, once again, requested to depute Welfare Officer/Senior Officer/any other Officer to get the information completed in revised Annexure – 1 (copy enclosed) correctly, get verify and signed by Head of Office and send to this office alongwith relevant documents within a week positively failing which the responsibilities will be fixed for non completion of information and over delaying the matter.

If candidate is not interested for appointment on compassionate ground in CGWB, the unwillingness may be obtained from him/her and sent to this office by email so that his case for compassionate appointment can be closed for ever. In the case of fresh cases, "**Proforma regarding employment of dependent of Government Servant dying while in service/retired on invalid pension**" (copy enclosed) and **revised Annexure – 1**(copy enclosed) may be got completed from any one of the family member of the deceased/retired Govt. Servant, if willing. Above HOOs are also requested to furnish name, designation, email ID and Mobile No. of Welfare Officer/Senior Officer/Any other Officer deputed to the concerned candidate on email ID : aamin-cgwb@gov.in by 1.11.2021 positively.

It may be ensured that complete information in Annexure – 1 alongwith required documents of the candidates mentioned in List is submitted to CHQ latest by 5.11.2021. Top Priority in the matter is solicited.


