Sub: Furnishing information in Revised Annexure - I for consideration of candidature for compassionate appointment in CGWB.

Sir,

I am directed to state that on non receipt of the essential information as on 01.01.2019, 01.01.2020 and 01.01.2021 i.e. details of family pension, monthly income, value of movable/immovable property, number of dependents, number of unmarried daughters and number of minor children from the candidates for compassionate appointment from the most of the candidates, they were requested vide this office letter dated 29.6.2021 (available on CGWB's website) to submit the details of family pension, monthly income, value of movable/immovable property, number of dependents, number of unmarried daughters and number of minor children as on 01st January, 2019, 01st January, 2020 and 01st January, 2021 in Annexure –I and sent within a week to concerned Office from where the Govt. Employee last served before his death. The concerned Heads of Offices were requested to verify the information furnished by the candidates, sign and send to this office by 29.7.2021.

But, Annexure – I duly verified, signed and forwarded by concerned Head of Offices not received from many candidates upto 4.8.2021. Therefore, again, 2nd letter was sent to concerned candidates on dated 4.8.2021 (available on CGWB's website) to furnish information within a week to concerned HOO. The concerned Head of offices have also requested to concerned candidates to furnish above information immediately. The 3rd letter was also sent on 9.9.2021 to the candidates, who had not sent information, to furnish information to concerned HOO within a week failing which their candidature would not be considered for compassionate appointment for Vacancy Year 2019, 2020 and 2021(Upto 31.7.2021). In spite of giving repeated chances to the candidates and repeated reminders, the persons mentioned in the enclosed List have failed to furnish information in Ann.-1, therefore, their names have been left out on their fault for consideration for compassionate appointment for the above period.

The 4th letter was sent on 21.12.2021 to the candidates, who had not sent information, to furnish information to concerned HOO within 10 days failing which their candidature would not be considered for compassionate appointment for Vacancy Year 2021(from 8/21 to 12/21).

The 5th letter was also sent on 03.03.2022 to the candidates, who had not sent information, to furnish information to concerned HOO within 10 days failing which their candidature would not be considered for compassionate appointment for Vacancy Year 2021(from 8/21 to 12/21). But till date 25 candidates have not completed the desired information.

It is, once again requested, If any vacancy will arise for the remaining period-01.08.2021 to 31.12.2021 of Vacancy Year 2021, the names of all the candidates will be considered who could complete information upto 25.04.2022. In case, the candidates again fail to complete information within the stipulated time, their names will not be considered for which they will be solely responsible.

All the candidates requested to update their Postal Address, Mobile No., Whatsapp Mobile No., email address on the official email ID of concerned Head of Office which is available on the CGWB's website and Email ID of Administrative Officer (Min. Estt) of CHQ – aomin-cgwb@nic.in. In case, any candidate is failed to update the above information and any communication sent by this office is not received by him/her, he/she will be liable for the same.

All the candidates mentioned in the enclosed List are once again requested to complete information in the **Revised Annexure** – I as on 1.1.2021, enclose necessary documents required in it and send to concerned Head of Office of CGWB, CGWA, RGI from where the Government Servant died while in service latest by 25.04.2022 under intimation to this office so that their names can be considered alongwith others. **No Annexure** – I directly sent by the candidates to this office will be entertained.

It may be noted that in spite of giving sufficient opportunities and time, if any candidate has not sent Revised Annexure-1 dully filled and signed by him/her to the concerned office latest by 25.04.2022 to concerned office and not found in this office latest by 30.04.2022 from the concerned Head of Office, his/her candidature for compassionate appointment for the period from 1.8.2021 to 31.12.2021 (if any vacancy arise) will not be considered by this office and he/she will be solely responsible for the same.
