In pursuance to the Ministry's letter No. A-32022/1/2019-(GW Estt.) Section dated 12.04.2019 and in terms of the instructions as laid down in Department of Personnel & Training O.M. No. 35034/3/2008-Estt.(D) dated 19.05.2009 and O.M. No. AB-14017/37/2008-Estt.(RR) dated 10.09.2010 and on the basis of recommendations of the Departmental Screening Committee, approval of the Competent Authority is hereby conveyed for grant of 3rd financial upgradation under Modified Assured Career Progression (MACP) Scheme from Grade Pay of Rs. 7600/- in PB-3 to Grade Pay of Rs. 8700/- in PB-4 (pre-revised) to the following Scientist 'D' and Programmer of Central Ground Water Board w.e.f. dates mentioned against each.

2. Sh. Suresh Chand Kapil, Scientist 'D' does not fulfil the benchmark as on 01.01.2018 and 01.01.2019 for grant of financial upgradation under MACP, hence upgradation under the scheme is not granted to him.


3. Sh. N. R. Bhagat, Scientist 'D' does not fulfil the benchmark as on 10.09.2010, as on 01.01.2011 and as on 01.01.2012.

4. Sh. K. N. Nagaraja, Scientist 'D' does not fulfil the benchmark as on 01.01.2012, as on 01.01.2013, as on 01.01.2014, as on 01.01.2015 and as on 01.01.2016.

5. On grant of financial upgradation under the MACPS, there shall be no change in the designation, classification or higher status. However, financial and certain other benefits, which are linked to the pay drawn by the officers shall be permitted.
6. With regard to fixation of pay on grant of financial upgradation under the MACPS, the officer has an option under FR 22(1)(a)(1) to get his pay fixed in the higher grade pay either from the date his financial upgradation or from the date of his next increment.
7. Grant of higher pay scale under the MACPS shall be conditional to the fact that when financial upgradation has been allowed and the officer subsequently refuses the promotion, it shall not be a ground to withdraw the financial upgradation.
8. On making fixation of pay, the officer concerned is advised to submit an undertaking to the effect that arrears of pay on account of granting financial upgradation under the MACPS will be subject to any audit objection etc. and he will refund the amount drawn by him as excess pay and allowances by virtue of higher pay scale in lump sum, in case it is found that the same is not applicable in his case.
9. While issuing pay fixation orders, a para may be added to the effect that the above fixation of pay in the upgraded scale is subject to review by audit. Any over payment on account of pay fixation in the upgraded scale as pointed out by the audit will be recovered from him in lump-sum.
10. The financial upgradation under the MACP Scheme shall be purely personal to the officers and shall have no relevance to his seniority position. As such, there shall be no additional financial upgradation for the senior officers on the ground that the junior officer in the grade has got higher scale under the MACP Scheme.
11. Care has been taken to finalize this order exactly as per details given in Ministry's letter No. A-32022/1/2019-(GW Estt.) Section dated 12.04.2019, referred above. However, in case of any changes in this order, which may be inadvertent / by mistake, Ministry's order will have precedence over this order.
