2. Since all the officials have been transferred in public interest, they are entitled to TTA and joining time as admissible under the existing TTA Rules.


3. They are advised to give their acceptance for promotion or otherwise within 10 days and report for further duty at their respective place of posting within 20 days from the date of issue of this order, failing which it will be presumed that the official is not willing to accept the promotion and the promotion order may be cancelled without waiting for any further reference.

4. The official/(s), whose promotion order is cancelled as per the terms mentioned in para-3 above, will be debarred for reconsideration for promotion to the post of Driller Incharge for a period of one year, in terms of Ministry of Home Affairs (DOP&AR)'s OM No.22054/3/81.Estt (D) 1.10.81.

5. The officials may exercise their option within a period of one month from the date of their taking over the charge to the promotional post, whether they will get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the present post. In case, they have already been granted MACP in Level-8 in the pay matrix, their pay will not be fixed.
