On the recommendation of the Departmental Promotion Committee (Group-B, Gazetted) and with the approval of the Chairman, CGWB the following Senior Technical Assistant (Hydrogeology) (Group-B Non-Gazetted) are hereby promoted to the post of Assistant Hydrogeologist (Group-B Gazetted) in level-8 in the pay matrix. Their place of posting on promotion is shown against their names:-

Their promotion will be effective from the date of assuming the charge to the post of Assistant Hydrogeologist.

They will be on probation for a period of two years from the date of their taking over the charge of the post of Assistant Hydrogeologist which can be extended by the Competent Authority at his discretion.

They may give option within one month from the date of taking over the charge of the post, whether they shall get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the lower scale. In case they have already been granted MACP, their pay will not be fixed.

They are advised to give their acceptance within 10 days from the date of receipt of order and report for duty at their respective place of posting within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days. It will be presumed that the official is not willing to accept the promotion and the promotion will be cancelled without waiting for

any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

Promotion order in respect of above officials is subject to further orders which may be passed by the Hon'ble Supreme Court as per DOP&T OM No.36012/11/2016-Estt.(Res) dated 06.07.2018.

In case of failure to report for duty on promotion, no fresh promotion order will be given to them for a period of one year in terms of Ministry of Home Affairs Office Memorandum No.22034/3/81-Estt (D) dated 01.10.81.

Since there is no change of place of posting of officials, they are not entitled to TTA and joining time as admissible under rules.
