Since there is no change in the place of posting of official appearing at Sr. No.1, 4, 8, 9 and 10 above, they are not entitled to TTA and joining time. Since there is change in place of posting on promotion in respect of Sr. No.2, 3, 5, 6, 7 and 11, they are entitled for TTA and joining time as admissible under the existing Rules.

They are advised to give their acceptance or otherwise within 10 days and report

for duty on promotion within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No request for extension of time for furnishing acceptance or otherwise for joining the post on promotion will be entertained.

They may give option within one month from the date of taking over the charge of the post, whether they shall get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP, their pay will not be fixed. However, they will get their pay at equal or next higher slot in level-4 of the pay matrix.

If above officials refuse to accept promotion, they shall not be eligible to be considered for further financial up-gradation under MACP Scheme till they agree to be considered for promotion again and the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal as per DOP&T OM No 35034/3/2008-Estt(D) dated 19.05.2009.

In case of failure to report for duty on promotion, no fresh offer of promotion will be given to them and they will be debarred from promotion for a period of one year in terms of Ministry of Home Affair (DOP&T)'s OM No. 22034/3/81-Estt(D) dated. 1.10.81.
