
3. The officers will be on probation for a period of two years from the date of their taking over charge of the post.

4. As per recommendation of Review DPC by UPSC, the Panel Year of Sh. S. Chakraborty may be read as 2013-14 for 2014-15 as recommended earlier by the Ministry's order No.7/19/2014 dated 7.12.2017.
5. The recommendation of the DPC will be subject to the outcome of OA No. 2117/2015 filed by Sh. R. K. Kalita, AHG and others, PB New Delhi and shall also be subject to the judgement dated 26.09.2018 of the Hon'ble Supreme Court of India in the SLP(C) No.30621/2011.
6. As per revised RRs notified vide GSR No.35 dated 22.02.2020, the post of Scientist-B (Jr. Hydrogeologist), Group-'A' is re-designated as Scientist 'B' (Hydrogeology) Group 'A'.
7. In case of failure to report for duty on promotion, no fresh promotion order to the post of Scientist-B (Jr. Hydrogeologist) will be given for a period of 01 year in terms of Ministry of Home Affairs O.M. No. 22034/3/81-Estt(D) dated 01.10.1981.
8. Since there is change in place of posting in respect of officers appearing at S.NOs 3,8 (Panel Year 2017-18), 5,6,12,14 and 15 (Panel Year 2018-19) are entitled for TTA and joining time as per rules.
