They may give option within one month from the date of taking over the charge of the post, whether they shall get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the lower scale. In case, they have already been granted MACP their pay will not be fixed. However, in the event of differences in pay the difference may be allowed as per rule.

Since, there is no change in the place of posting on promotion of officials they are not entitled for TTA and joining time as per rules.
