OFFICE ORDER No. 781 Of 2022

In pursuance to Ministry of Jal Shakti, Department of Water Resources, RD & GR, Order issued under letter No. A-32012/10/2022-GWE (Estt.) dated 01.12.2022, Sh. P. S. Meena, Chief Draftsman (Group 'B' post) of the Central Ground Water Board is hereby promoted to the post of Artist (Group 'A') in Level -10 of Pay Matrix (pre-revised scale of pay in PB-3, Rs. 15600-39100/- + Grade Pay of Rs. 5400/-) with his place of posting at CGWB, WR, Jaipur

His promotion will be effective from the date of his assumption of charge to the post of Artist.

He will be on probation for a period of two years from the date of his taking over the charge of the post.

The officer may exercise his options within a period of one month from the date of his taking over the charge of the post in case he wish to get his pay fixed in the new post after the date of his increment in the present post.

He is advised to give his acceptance within 10 days from the date of receipt of this order and report for duty at his respective place of posting within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period or officer fails to join duty within 20 days, it will be presumed that the officer is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No request for extension of time for joining duty will be entertained.

In case of failure to report for duty on promotion, no fresh promotion order to the post of Artist will be given for a period of 01 (one) year in terms of Ministry of Home Affairs O.M. No. 22034/3/81-Estt(D) dated 01.10.1981.

Since, there is no change in the place of posting of officer he is not entitled for TTA and joining time as per rules.
