They are advised to give their acceptance for promotion or otherwise within 10 days and report for further duty at their respective place of posting within 20 days from the date of issue of this order, failing which it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference.
