OFFICE ORDER NO. 161 OF 2022

In pursuance to DoWR's Order No.A.32011/3/2018-GWE Section dated 11th March, 2022 and in compliance of Hon'ble High Court, Delhi common Order dated 01.09.2017 in WP (C) No.9413/2016 filed by Union of India Vs Shri S.K. Naik & others and WP (C) No.1473/2017 filed by Union of India Vs Sh. S.K. Swaroop & others, a committee was constituted for considering cut off date for granting the benefit of FCS to the grade Group 'B' Scientific Officer of CGWB based on the fact that 16 Group 'B' officers have been granted benefit of in-situ promotion under Flexible Complementing Scheme (FCS).

2. The recommendations of the Committee was examined and with the approval of Secretary (WR, RD & GR), the cut off date for granting the benefit of FCS to the Group 'B' Scientific Officers was decided as on 30.09.2004 and the officers inducted in service after 09.11.1998 may be granted the benefit of FCS with the bottom line for induction date for group 'B' Scientific Officers as on 30.09.2004 and the officer who joined service after 30.09.2004 shall not be considered for grant of benefit of FCS.

3. Accordingly, Board of Assessment (BOA) meetings were held in UPSC. The approval of the competent Authority is hereby conveyed for grant of promotion on 'in-situ' basis to the following Group 'B', Scientific Officers to the grade of Scientist 'B' in the Level - 10 of the Pay Matrix (pre-revised PB-3, Rs. 15600-39100/- + Grade Pay of Rs. 5400/-) and 01 (one) Group 'B' Scientific Officer to the grade of Scientist 'C' in the Level - 11 of the Pay Matrix (pre-revised PB-3, Rs. 15600-39100/- + Grade Pay of Rs. 6600/-) under Flexible Complementing Scheme (FCS) in Central Ground Water Board with effect from the date of eligibility given against each:-


