OFFICE ORDER NO. 454 OF 2016

On the recommendations of DPC Group "B" and with the approval of the Competent Authority, the following Asstt. Driller-Cum- Mechanic are hereby promoted to the post of Driller-Cum-Mechanic in the pay scale in PB-2, Rs.9300-34800/- with Grade Pay Rs.4200/- with their place of posting as shown against each. Their promotion will take effect from the actual date of joining to the promotional post at the new place of posting:

There is change in place of posting in respect of Sr. No. 2 and 3 above, hence they are entitled to TA/DA and joining time as admissible under the rules. Others are posted at the same place of posting on promotion, hence they are not entitled to TA/DA and joining time as per rule.

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of this order and report for duty at their new place of posting within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the post of promotion will be entertained.

They may give option within one month from the date of taking over the charge of the post, whether they shall get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP, their pay will not be fixed. However, the difference of grade pay, if any may be allowed as per rules.

In case of failure to report for duty on promotion within the stipulated period, they will be debarred from promotion for one year and no fresh offer of promotion will be given during debar period in terms of Ministry of Home Affairs (DOP&T)'s OM No. 22034/3/81-Engg.Esst.(D)dt.1.10.81.
