**OFFICE ORDER NO. 284 OF 2017**

On the recommendations of DPC Group "B" and with the approval of the Competent Authority, the following Asstt. Drillers-Cum- Mechanic are hereby promoted to the posts of Driller-Cum-Mechanic in Level-6 in the pay Matrix with their place of posting as shown against each. Their promotion will take effect from the actual date of their joining to the promotional post at the new place of posting:-

Since there is no change in place of posting of the above officials, they are not entitled to TA/DA and joining time as per rule.

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of this order and report for duty at their new place of posting within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the post on promotion will be entertained.

They may give option within one month from the date of taking over the charge of the post, whether they shall get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP, their pay will not be fixed. However, they will get their pay at equal or next higher slot in level-6 of the pay matrix.

If above officials refuse to accept promotion, they shall not be eligible to be considered for further financial up-gradation till they agree to be considered for promotion again and the second the next financial up-gradation shall also be deferred to the extent of period of debarment due to the refusal as per DOP&T OM No 35034/3/2008-Estt (D) dated 19.05.2009.

In case of failure to report for duty on promotion within the stipulated period, they will be debarred from promotion for one year and no fresh offer of promotion will be given during debar period in terms of Ministry of Home Affairs (DOP&T)'s OM No. 22034/3/81-Engg.Estt.(D)dt.1.10.81.
