OFFICER ORDER NO. 679 OF 2016

On the recommendation of the Departmental Promotion Committee (Group. 'B' Gazetted) and with the approval of the Competent Authority, the following Senior Technical Assistants (Geophysicist) are hereby promoted to the post of Assistant Geophysicist (Group 'B' Gazetted) in the pay matrix-8 pre-revised pay band - 2 and corresponding pay scale of Rs. 9300-34800/- plus Grade pay of Rs. 4800/-. Their place of posting on promotion is shown against their names. The promotion will take effect from the date of their actual joining of duty.

They are advised to give their acceptance within 10 days from the date of receipt of order and report for duty at their respective place of posting within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

In case of failure to report for duty on promotion, no fresh promotion order will be given to them for a period of one year in terms of Ministry of Home Affairs Office Memorandum No. 22034/3/81-Estt (D) dated 1.10.81.

Since the above officials have not been granted any financial up-gradation under the MACP Scheme hence they will get the pay fixation benefit on their promotion to the post of Assistant Geophysicist.

The transfer on promotion in respect of Sh. Prem Prakash Dookia, Senior Technical Assistant (Geophysicist) appearing at Sl. No. 1 above have been ordered in public interest, he will be entitled for TA/DA and joining time as admissible under the rules. Since there is no change in place of posting in respect of Smt. Sunita Devi, Senior Technical Assistant (Geophysicist), hence she is not entitled for TA/DA and joining time as per rules.
