OFFICE ORDER No. 625 of 2021

In pursuance to Ministry of Jal Shakti, Department of WR, RD & GR Office Order issued under letter No. A-32012/9/2021-GWE (Estt.) dated 02.11.2021, the following Assistant Geophysicists (Group 'B') of the Central Ground Water Board are hereby promoted to the post of Scientist 'B' (Geophysics) (Group 'A') in Level -10 of Pay Matrix (pre-revised scale of pay in PB-3, Rs. 15600-39100/- + Grade Pay of Rs. 5400/-) with their place of posting mentioned against their names as given below:-

Their promotion will be effective from the date of their assumption of charge to the post of Scientist 'B' (Geophysics).

They will be on probation for a period of two years from the date of their taking over the charge of the post of Scientist 'B' (Geophysics).

The officers may exercise their options within a period of one month from the date of their taking over the charge of the post in case they wish to get their pay fixed in the new post after the date of their increment in the present post.

They are advised to give their acceptance within 10 days from the date of receipt of this order and report for duty at their respective place of posting within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period or officer fails to join duty within 20 days, it will be presumed that the officer is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No request for extension of time for joining duty will be entertained.

In case of failure to report for duty on promotion, no fresh promotion order to the post of Scientist 'B' (Geophysics) will be given for a period of 01 (one) year in terms of Ministry of Home Affairs O.M. No. 22034/3/81-Estt(D) dated 01.10.1981.

Since, there is no change in the place of posting of officers appearing at Sl. 1 and 2, they are not entitled for TTA and joining time as per rules. There is change in place of posting of officer appearing at Sl. 3, he is entitled for TTA and joining time as per rules.
