In pursuance to Ministry's Office Order issued under letter No. 7/22/2015-CGWB dated 10th March 2016, the following Assistant Chemists of the Central Ground Water Board are hereby promoted to the post of Scientist 'B' (Chemist) in the PB-3 and corresponding pay scale of Rs. 15600-39100/- with Grade Pay of Rs. 5400/- with their place of posting is mentioned against their names as given below:-

Their promotion will be effective from the date they assumed the charge to the post of Scientist 'B' (Chemist).

They will be on probation for a period of two years from the date of their taking over the charge of the post of Scientist 'B' (Chemist).

On promotion to the post of Scientist 'B' (Chemist), they will exercise an option within one month from the actual date of taking over the charge of the post, whether they will get the pay fixed in the new post either straightway or from the date of promotion of from the date of their next increment in the old scale.

They are advised to give their acceptance within 10 days from the date of receipt of this order and report for duty at their respective place of posting within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period or officer fail to join their duty within 20 days, it will be presumed that the officer is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No request for extension of time for joining duty will be entertained.

In case of failure to report for duty on promotion, no fresh promotion order to the post of Scientist 'B' (Chemist) will be given for a period of 01 year in terms of Ministry of Home Affairs O.M. No. 22034/3/81-Estt(D) dated 01.10.1981.

Since there is no change in the place of posting in respect of above officers, hence they are not eligible for TA/DA and joining time.
