OFFICE ORDER NO. 336 OF 2016

On the recommendation of the DPC (Group 'B' Gazetted) and with the approval of the Competent Authority, **Dr. Harbhajan Meena, Senior Technical Assistant (Chemical) is hereby promoted to the post of Assistant Chemist** (Group 'B' Gazetted) in the Pay Band-2 and correspondence pay scale of Rs. 9300-34800/- plus Grade pay of Rs. 4800/- with his place of posting at his present place of posting i.e. CGWB, WCR-Ahmedabad.

His promotion will be effective from the date of his assuming the charge to the post of Assistant Chemist.


He will be on probation for a period of two years from the date of his taking over the charge of the post of Assistant Chemist which can be extended by the competent authority at his discretion.

On promotion to the post of Assistant Chemist, he may exercise option within one month from the actual date of taking over the charge of the post, whether he will get the pay fixed in the new post either straightway or from the date of promotion from the date of his next increment in the old pay scale.

He is advised to give his acceptance within 10 days from the date of receipt of this order and report for duty at his respective place of posting within 20 days from the date of issue of this order. In case, the acceptance is not received within the stipulated period or officer fail to join his duty within 20 days, it will be presumed that the officer is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No request for extension of time for joining duty will be entertained.

In case of failure to report for duty on promotion, no fresh promotion order to the grade of Assistant Chemist will be given for a period of one year in terms of Ministry of Home Affairs O.M. No. 22034/3/81-Estt.(D) dated 01.10.1981.

Since there is no change in the place of posting, hence he will not be entitled for TA/DA and joining time.
