
Their promotion will take effect from the actual date of their joining to the promotional post. Since, there is no change in place of posting of the above officials, they are not entitled for TTA & joining time as per rules.

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of order and report for duty at their place of posting on promotion within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the officials are not willing to accept the promotion and their promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

They may give option within one month from the date of taking over the charge of the post, whether they will get the pay fixed in the new post either straightaway from the date of joining on promotion to the new post or from the date of their next increment in the level or lower post. In case they have already been granted MACP their pay will not be fixed. However, in the event of differences in Pay the deference may be allowed as per rule.

Promotion order in respect of above officials is subject to further orders which may be passed by the Hon'ble Supreme Court as per DoP&T OM No. 36012/11/2016-Estt.(Res-I) (Pt-II) dated 15.06.2018.

In case of failure to report for duty on promotion, they will be debarred for promotion for a period of one year in terms of Ministry of Home Affairs, OM No. 22034/3/81-Estt(D) dated 01.10.81.

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of this order and report for duty at their place of posting on promotion within 30 days from the date of order. In case the acceptance is not received within the stipulated period of 10 days, it will be presumed that the officials are not willing to accept the promotion and their promotion order will be cancelled without waiting for any further intimation. The extension of time for forwarding acceptance or otherwise for joining the station on promotion will be considered.

They may give order within one month from the date of taking over the charge of the post, whether they get the pay fixed in the new post or their next increment in the level or lower than the promotion to the new post or in the date of their next increment in the level or lower post, in case they have already been granted MAT, their pay will not be fixed. However, in the event of intimation to pay the intimation may be allowed as per rules.

Promotion order in respect of above officials is subject to further orders which may be issued by the Hon'ble Supreme Court as per Deptt. OM No. 36012/12016-Ext. (Head) (P-II) dated 16.08.2016.

In case of failure to report for duty on promotion, they will be deemed to be absent for a period of one year in terms of Ministry of Home Affairs, OM No. 1204/1981-Ext. (P-II) dated 01.10.81.
