OFFICE ORDER

In pursuance of Ministry's Office Order No 7/14/2016-CGWB dated 19.10.2016, the following Assistant Executive Engineers of Central Ground Water Board are hereby promoted to the Post of Executive Engineer in Level-11 of the Pay Matrix (Pre-revised pay scale PB-3 Rs.15600-39100/-plus Grade Pay Rs 6600/-) with effect from the date of their taking over the charge to the promotional post at their new place of posting shown against their respective names:-

Since there is no change in place of posting in respect of Serial no 2 on promotion, he is not entitled to TA and Joining time. There is change in place of posting in respect of Serial no 1, 3, 4 and 5 hence they are entitled to TA and joining time as admissible under the existing TTA Rules.

They are requested to give their acceptance for promotion or otherwise within 10 days from the date of receipt of this order and report for duty at their respective place of posting within 20 days from the date of issue of this order failing which it will be presumed that the officials are not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference.

The Officers may exercise their option within a period of one month from the date of their taking over the charge to the promotional post, whether they will get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the present post. In case, they have already been granted MACP, their pay will not be fixed.

In case of failure to report for duty on promotion, no fresh offer of promotion will be given to the above officers and they will be debarred for a period of one year in terms of Ministry of Home Affairs (DOP&T)'s OM No. 22054/3/81.Estt (D) 1.10.81.

Further to the above, the promotion of the above officers will be subject to the outcome of Review DPC as per the direction issued by the Hon'ble CAT Jodhpur Bench in OA No 19/2013 filed by Sh.C.R.Chahilya and any other court case pending in this regard.

This issues with the approval of Chairman, CGWB.
