Their promotion will take effect from the actual date of their joining to the promotional post.

Since, there is no change in place of posting of the above officials, they are not entitled for TTA & joining time as per rules.

In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the officials are not willing to accept the promotion and their promotion order will be cancelled without waiting for any further reference. They may give option within one month from the date of taking over the charge of the post, whether they will get the pay fixed in the new post either straightaway from the date of joining on promotion to the new post or from the date of their next increment in the level or lower post. In case they have already been granted MACP their pay will not be fixed. However, in the event of differences in Pay the deference may be allowed as per rule.
