On the recommendations of the DPC and approval of the Competent Authority, Smt. P. D. Asha, Office Superintendent is hereby promoted to the post of Administrative Officer (Group-B, Gazetted) in Level 8 in the 'Pay Matrix' with her posting at CGWB, NCR, Bhopal.

Her promotion will take effect from the actual date of her joining to the promotional post.

Since there is no change in place of posting on promotion, she is not entitled for TTA and joining time as per rules.

She is advised to give her acceptance or otherwise within 10 days from the date of receipt of order and report for duty at her place of posting on promotion within 20 days from the date of issue of order.
