OFFICE ORDER NO. 101 OF 2016.

On the recommendation of the DPC Group'B'(Non-Gazetted) and with the approval of the Chairman, CGWB, Smt. Lovabati Mallik, UDC, CGWB, Division-X, Bhubaneswar is hereby promoted to the Post of Assistant on Ad hoc basis in the pay scale of PB 2 Rs 9300-34800/- with Grade Pay Rs 4200/- with her place of posting at CGWB, Division-X, Bhubaneswar with effect from the date of her taking over the charge to the promotional post.

The promotion is being made on purely ad hoc basis and the ad hoc promotion will not confer any right for regular promotion.


The promotion shall be until further orders. The government reserves the right to cancel the ad hoc promotion at any time and revert her to the post from which she has been promoted.

Since there is no change in place of posting on adhoc promotion, she is not entitled to TA and Joining time.

She is requested to give her acceptance for promotion or otherwise within 10 days from the date of receipt of this order and report for duty at her respective place of posting within 20 days from the date of issue of this order failing which it will be presumed that She is not willing to accept the adhoc promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the promotional post will be entertained.

She may exercise her option within period of one month from the date of her taking over the charge of the promotional post, whether she will get the pay fixed in the new post either straightway from the date of joining on adhoc promotion to the new post or from the date of her next increment in the old scale. In case, she has already been granted MACP her pay will not be fixed. However, in the event of differences of grade pay, the difference may be allowed as per rule.

In case of failure to report for duty on promotion, no fresh offer of promotion will be given to her.

OFFICE ORDER NO. 100 OF 2016.

On the recommendation of the DPC Group'B'(Non-Gazetted) and with the approval of the Chairman, CGWB the following UDCs of Central Ground Water Board are promoted to the Post of Assistant in the pay scale of PB 2 Rs 9300-34800/- with Grade Pay Rs 4200/- with effect from the date of their taking over the charge to the promotional post at their new place of posting shown against their respective names:-

Since there is no change in place of posting in respect of Serial no 1 and 6 on promotion, they are not entitled to TA and Joining time. There is change in place of posting in respect of Serial no 2 to 5, hence they are entitled to TA and joining time as admissible under the existing TTA Rules.

They are requested to give their acceptance for promotion or otherwise within 10 days from the date of receipt of this order and report for duty at their respective place of posting within 20 days from the date of issue of this order failing which it will be presumed that the officials are not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the promotional post will be entertained.

If they are not interested on promotion on transfer their continuance in the capacity of UDC at the same station will be allowed only on a written request from the official. In case no such request for refusal of promotion is received within stipulated period, the official will be stand relieved with instruction to proceed to the new place of posting on promotion. It is reiterated that due to non-availability of vacancy at the same station it will not be possible to consider their request for retention on promotion at the same station and no such representation should be forwarded to CHQ for consideration.

They may exercise their option within period of one month from the date of their taking over the charge of the promotional post, whether They will get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP their pay will not be fixed. However, in the event of differences of grade pay, the difference may be allowed as per rule. - (327)

In case of failure to report for duty on promotion, no fresh offer of promotion will be given to the above officers and they will be debarred for a period of one year in terms of Ministry of Home Affairs (DOP&T)'s OM No. 22054/3/81.Estt (D) 1.10.81.
