OFFICE ORDER NO. 217 OF 2017


Since, there is no change in the place of posting of above mentioned officials, they are not entitled to TA/DA and joining time as per rule

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of order and report for duty at their place of posting on promotion within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the officials are not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

They may give option within one month from the date of taking over the charge of the post, whether they will get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP their pay will not be fixed. However, they will be placed in the index of the level applicable to the promotional post.

While issuing pay fixation orders, a Para may be added to the effect that the above fixation of pay in the promoted level is subject to review by audit. Any over payment on account of pay fixation in the upgraded scale as pointed out by the audit will be recovered from them in lump sum.

In case of failure to report for duty on promotion, they will be debarred for promotion for a period of one year in terms of Ministry of Home Affairs, O.M. No. 22034/3/81-Estt.(D) dated 01.10.1981.
