Since, there is no change in the places of posting of Sl. 1, 2, 4 and 5, they are not entitled for TTA and joining time as per rule. Whereas, Sl. No. 3 is entitled for TTA and joining time as per rules.

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of order and report for duty at their place of posting on promotion within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the official is not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference.
