

Since, there is no change in place of posting on promotion in respect of the above officials, they are not entitled for TA/DA and joining time as per rules.

They are advised to give their acceptance or otherwise within 10 days from the date of receipt of order and report for duty at their place of posting within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the officials are not willing to accept the promotion and their promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the station on promotion will be entertained.

They may exercise option within one month from the date of taking over the charge of the post, whether they will get the pay fixed in the new post either straightaway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case they have already been granted MACP, their pay will not be fixed. However, the difference of grade pay will be granted to them as per rule.

In case of failure to report for duty on promotion, no fresh offer of promotion will be given to the officials for a period of one year in terms of Ministry of Home Affairs, OM No. 22034/3/81-Estt(D) dated 1.10.81.
