OFFICE ORDER NO. 179 OF 2016.

On the recommendation of the DPC Group 'B' (Gazetted) and with the approval of the Chairman, CGWB the following Office Superintendents of Central Ground Water Board are promoted to the Post of Administrative Officer in the pay scale of PB 2 Rs 9300-34800/- with Grade Pay Rs 4800/- with effect from the date of their taking over the charge to the promotional post at their new place of posting shown against their respective names but not earlier 01.04.2016

Since there is no change in place of posting in respect of Serial no 1,3,4,5,6, 8 and 9 on promotion, they are not entitled to TA and Joining time. There is change in place of posting in respect of Serial no 2,7,10, 11 to 12, hence they are entitled to TA and joining time as admissible under the existing TTA Rules.

They are requested to give their acceptance for promotion or otherwise within 10 days from the date of receipt of this order and report for duty at their respective place of posting within 20 days from the date of issue of this order failing which it will be presumed that the officials are not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining the promotional post will be entertained.

If they are not interested on promotion on transfer their continuance in the capacity of Office Superintendent at the same station will be allowed only on a written request from the official. In case no such request for refusal of promotion is received within stipulated period, the official will be stand relieved with instruction to proceed to the new place of posting on promotion.

They may exercise their option within period of one month from the date of their taking over the charge of the promotional post, whether They will get the pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old scale. In case, they have already been granted MACP their pay will not be fixed. However, in the event of differences of grade pay, the difference may be allowed as per rule.

In case of failure to report for duty on promotion, no fresh offer of promotion will be given to the above officers and they will be debarred for a period of one year in terms of Ministry of Home Affairs (DOP&T)'s OM No. 22054/3/81.Esst (D) 1.10.81.
