OFFICE ORDER NO. 275 OF 2017

1 MAY 2017

In pursuance to Ministry's office order No.7/24/2015-CGWB dated 28th April 2017 and in compliance of the Judgment dated 26.04.2014 in O.A. No. 1182/2012 filed by Sh. Anmol Sharma and 10 Others and Hon'ble CAT, PB, New Delhi Order dated 20.12.2016 in Contempt Petition No. 279/2015 in the said O.A. and Hon'ble High Court, Delhi interim Order dated 06.12.2016 in WP (C) No. 9413/2016 filed by U.O.I. in the matter of Sh. Sanjay Naik & others, a meeting of the Board of Assessment were held on 09.02.2017 to consider the following proposals:-

- (i) BOA proposal for consideration of in-situ promotion of 11 (eleven) Group 'B' Scientific Officers (PB-2, 9300-34800/- +GP 4800/-) to the grade of Scientist 'B' (PB-3, Rs.15600-39100/- +GP Rs.5400/-) under Flexible Complimenting Scheme (FCS) in Central Ground Water Board respect(CGWB) in the context of above mentioned Contempt Petition No.279/2015 filed by Sh Anmol Sharma and 10 Others in OA No.1182/2012 in the Hon'ble CAT,PB, New Delhi.
- (ii) BOA proposal for consideration of in-situ promotion of 30 Group B (Scientific) officers to the grade of Scientist 'B' under FCS in CGWB as per Hon'ble High Court, Delhi interim order dated 6.12.2016 in WP(C) No.9413/2016 filed by UOI in the matter of Shri Sanjay Naik & Others. The operative part of said interim order is reproduced as under:-

"In case any Departmental Promotion Committee meeting held in respect of Group B employees, the case of the respondents will be also put up and examined in the said meeting, but the results would not be declared."

2. The Board of Assessment assessed the suitability of Group B Scientific Officers. In light of interim order dated 06.12.2016 passed by Hon'ble High Court Delhi in WP(C) No 9413/2016 in the matter of Shri Sanjay Naik & Others, out of 11 (eleven) applicants, in the present matter of Anmol Sharma and 10 Others, three applicants namely **S/Shri Pramod Kumar Verma, Ashwin Kumar Atey and Sanjay Kumar Naik**, are common in the same cause of action and the reliefs sought thereto. Hence results of 8 (eight) applicants out of 11(eleven) applicants, **except 3 (three),namely S/Shri Pramod Kumar Verma, Ashwin Kumar Atey and Sanjay Kumar Naik**, who are applicants in the OA No.1182/2012 and are also party in the WP No.9413/2016 in the matter of Sanjay Kumar Naik & others, are to be declared.

3. Accordingly, approval of the Competent Authority is hereby conveyed for grant of promotion on 'in-situ' basis to the following Group B Scientific Officers (Assistant

Hydrogeologist) in PB-2 of Rs.9300-34800 + Grade Pay Rs.4800/- to the grade of Scientist 'B' in PB-3 of Rs.15600-39100 + Grade Pay Rs.5400/- under the Flexible Complementing Scheme (FCS) with effect from the dates/years of eligibility given against each:


4. The promotion of the above officers to the grade of Scientist 'B' under the FCS will be in situ and personal to the officer concerned.

5. They may exercise their option within a period of one month from the date of their taking over the charge of the post in case they wish to get their pay fixed in the new post after the date of their increment in the present post.

6. In case any of the officers is on leave on the respective date of his/her promotion, he/she shall assume charge of the Grade of Scientist B from the date he/she had resumed the duty.

7. They are entitled for all consequential benefits.

8. The promotion order of the above mentioned officers are subject to the outcome of ongoing court cases, if any.
