## OFFICE ORDER No. 370 Of 2022

On the recommendations of the DPC and with the approval of the Competent Authority, Sh. Anil Kumar Mittal, Office Superintendent, CGWB, CHQ, Faridabad is hereby promoted to the post of Administrative Officer (Group-B, Gazetted) in Level 8 in the 'Pay Matrix' with his posting at CHQ, CGWB, Faridabad.

His promotion will take effect from the actual date of her joining to the promotional post.

Since there is no change in place of posting on promotion, he is not entitled for TTA and joining time as per rules.

In case, he has already been granted MACP his pay will not be fixed. However, in the event of differences in pay the difference may be allowed as per rules.
