The above mentioned officials are advised to give their acceptance or otherwise within 10 days from the date of receipt of order and report for duty at their place of posting on promotion within 20 days from the date of issue of order. In case, the acceptance is not received within the stipulated period of 10 days, it will be presumed that the officials are not willing to accept the promotion and the promotion order will be cancelled without waiting for any further reference. No extension of time for furnishing acceptance or otherwise for joining on promotion will be entertained.

They may give their option within one month from the date of taking over the charge of the post, whether they will get their pay fixed in the new post either straightway from the date of joining on promotion to the new post or from the date of their next increment in the old Level of Pay Matrix.
