सा.का.िन. 201.—राष्ट्रपति, संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, केन्द्रीय भूमिगत जल बोर्ड (ज्येष्ठ प्रशासनिक अधिकारी) भर्ती नियम, 2005 का और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात्:-

  - (2) ये राजपत्र में प्रकाशन की तारीख को प्रवृत्त होंगे।
- 2. केन्द्रीय भूमिगत जल बोर्ड (ज्येष्ठ प्रशासनिक अधिकारी) भर्ती नियम, 2005 की अनुसूची में;-
  - (i) "स्तंभ 4" में
    - (क) स्तंभ के शीर्षक के स्थान पर निम्नलिखित स्तंभ शीर्षक रखा जाएगा; अर्थात्:-
    - "वेतन मैट्रिक्स में स्तर";
    - (ख) प्रविष्टियों के स्थान पर निम्नलिखित प्रविष्टियां रखी जाएगी; अर्थात्:-
    - "वेतन मैट्रिक्स में स्तर-11";
  - (ii) "स्तंभ 12 में"; -

    - ''वेतन मैट्रिक्स में स्तर-9'' अंक और शब्द रखे जाएंगे।

- (1) These rules may be called the Central Ground Water Board (Senior Administrative Officer) Recruitment

Note: Where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying or eligibility service.

Deputation: Officers under the Central/State Governments and Union Territories:—

- (a) (i) holding analogous posts on regular basis in the parent cadre/ department; or
- (ii) with five years service in the grade rendered after appointment thereto on a regular basis in the scale of Rs. 9300—34800 with grade pay of Rs. 5400 in the Pay Band 2 or equivalent in the parent cadre/department; and
- (b) possessing the educational qualifications and experience as under;
- (i) Bachelor's Degree of a recognized University/Institution; and
- (ii) five years experience in handling administration, establishment and financial matters.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding 56 years, as on the closing date of receipt of applications.
