Notification

New Delhi, the _____, 2023.

GSR.....- In exercise of the power conferred by the proviso to article 309 of the Constitution and in supersession of the Central Ground Water Board, Assistant Hydrogeologist, Recruitment Rules, 2019, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Hydrogeologist in the Department of Water Resources, River Development and Ganga Rejuvenation, Ministry Of Jal Shakti namely:-

1. **Short title and commencement**– (1) These rules may be called the Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation, Central Ground Water Board, Assistant Hydrogeologist (Group ‘B’ Post) Recruitment Rules, 2023.
(2) They shall come into force on the date of their publication in the Official Gazette.
2. **Number of post, classification and level in pay matrix.** - The number of post, its classification and level in the pay matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
3. **Method of recruitment, age-limit, qualifications, etc.** – The method of recruitment, age-limit, qualifications and other matters relating thereto, shall be as specified in columns (5) to (13) of the aforesaid Schedule.
4. **Disqualification.** – No person-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having a spouse living, has entered into or contracted a marriage with any person,shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.
5. **Power to relax.** – Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provision of these rules with respect to any class or category of persons.
6. **Saving**– Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Schedules Tribes, The Other Backward Classes, ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Recognised University or Institute or Research Institution;

(a) (i) holding analogous posts on a regular basis in the parent cadre or department; or

(ii) With two years regular service rendered after appointment to the posts in the level-7 (Rs.44900-142400/-) in the pay matrix in the parent cadre or department; and

(b) Possessing the educational qualifications prescribed for direct recruits in Column (7); and

(c) Having at least two years working experience in the field of Hydrogeology from recognized Organization or institute.

Note (1): The departmental officer in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note (2): Period of deputation (Including short term contract) including period of deputation (Including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years. The maximum age limit for appointment by deputation (including short term contract) shall not be exceeding fifty-six years as on the closing date of receipt of application.
