

Notification

G.S.R.____.- In exercise of the powers conferred by proviso to article 309 of the Constitution and in supersession of the Central Ground Water Board Assistant Geophysicist Recruitment Rules, 1995, Central Ground Water Board Assistant Geophysicist Recruitment (Amendment) Rules, 2001 and Central Ground Water Board Assistant Geophysicist Recruitment (Amendment) Rules, 2017, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Geophysicist in the Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation, Central Ground Water Board, namely:-

1. Short title and commencement.- (1) These rules may be called the Central Ground Water Board Assistant Geophysicist Recruitment Rules, 2023.

(2) They shall come into force on the date of their publication in the official Gazette.

2. Number of post, classification and Level in the pay matrix.- The number of said post, its classification and Level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit, qualifications, etc. - The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.

4. Disqualifications.- No person,

(a) who has entered into or contracted a marriage with a person having a spouse living; or
(b) who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax. - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, ex-servicemen, and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years whichever is less and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have completed such qualifying eligibility service.

Deputation:

Officers under the Central Government-

(a) (i) holding analogous posts on regular basis or
(ii) with three years regular service in posts in the scale of Rs.6500-10500 or equivalent and

(b) Having experience in the actual conduct of Geophysical Survey work particularly with reference to Ground Water and possessing educational qualifications prescribed for direct recruits in Column 8.

Note 1: Departmental officers in the feeder grade who are in direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
