#### Notification

- G.S.R.\_\_\_\_\_\_. In exercise of the powers conferred by proviso to article 309 of the Constitution and in supersession of the Central Ground Water Board (Director Administration) Recruitment Rules, 1997, Central Ground Water Board Director (Administration) Recruitment (Amendment) Rules, 2000 and Central Ground Water Board Director (Administration) Recruitment (Amendment) Rules, 2018, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Director (Administration) in the Ministry of Jal Shakti, Department of Water Resources, River Development and Ganga Rejuvenation, Central Ground Water Board, namely:-
- 1. Short title and commencement.- (1) These rules may be called the Central Ground Water Board Director (Administration) Recruitment Rules, 2023.
- (2) They shall come into force on the date of their publication in the official Gazette.
- 2. Number of post, classification and Level in the pay matrix. The number of said post, its classification and Level in the pay matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications, etc. The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
- 4. Disqualifications.- No person,-
- (a) who has entered into or contracted a marriage with a person having a spouse living; or (b)who having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax. - Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation

with Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, ex-servicemen, and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation:

Officers under the Central Government or State Governments or Union Territories/ Officers of All India Services and Organized Group 'A' Services of the Central Government;

- (a) (i) holding analogous posts on regular basis in the parent cadre or department; or
- (ii)with three years regular service in the post in level-12 (Rs.78800-209200) in pay matrix in the parent cadre or department; or
- (iii)with eight years regular service in the post in level-11 (Rs.67700-208700) in pay matrix in the parent cadre or department; and
- (b) having twelve years experience in establishment, personnel management, administration and accounts matters and having a thorough knowledge of Government rules and procedures.

(Period of deputation (including short-term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed five years. The maximum age —limit for appointment by deputation (including short—term contract) shall not be exceeding fifty six years as on the closing date for receipt of application).

# Deputation/Re-employment (for Armed Forces Personnel)/Absorption:

Armed Forces personnel of the rank of Colonel or equivalent who are due to retire or are to be transferred to reserve with a period of one year and having the experience prescribed above shall also be considered. If selected, such persons would be given deputation terms upto the date on which they are due for release from the Armed force and thereafter they may be continued on re-employment basis. In case such eligible officers have retired before the actual selection to the post is made, their appointment will be on re-employment basis (Re-employment upto the age of superannuation with reference to Civil posts).
