- 1. The firm must be in business of 'AMC of EPABX system' for at least 3 (three) years.
- 2. The firm must be registered firm and should have PAN, GST etc...
- 3. The firm must have infrastructural facilities at Delhi / NCR.
- 4. The firm must have performed at least one similar type of contract in a Government Department during last three years in Delhi / NCR.

The terms & conditions as detailed below are to be followed by the Contractor:-

- 1. The tenure of the contract will be for a period of one year starting from the date of awarding the AMC to the successful bidder, which can be extended further for one year in case of satisfactory performance.

- 4. The contactor will maintain a call register and make service report to this office before quarterly release of the payment.
- 5. It will be ensured by the Contractor to attend the complaint within 24 to 48 hrs., otherwise a penalty of Rs.100/- per day will be charged from the Contractor. The working days are from Monday to Friday from 09:00 to 17:30 hrs. IST.
- 6. The Head of Office reserves the right to terminate the contract after giving one month's notice in case it is felt that the contractor has failed to fulfil the required terms and conditions. In this connection decision of the Head of Office shall be final and binding upon the contactor.
- 7. The final rate of AMC will not be enhanced during the AMC period.
- 8. The Contractor will not sublet the award to anybody during the contract period.

- 9. The Bidder shall deposit 'Earnest money' of ₹ 5000/- (₹ Five thousand only) with the quotation as Demand Draft in favour of <u>"DDO, CGWB, Faridabad"</u>. The Earnest money received from the bidders will be returned without interest immediately after the process of selection is over.
- 10. The successful bidder would be required to deposit <u>Security amount</u>, of <u>10% of the final amount of AMC order</u>, in form of <u>Demand Draft in favour of "DDO</u>, <u>CGWB, Faridabad"</u> within 5 (five) working days of the receipt of the AMC Order, which shall be refunded only after the expiry of the Contract successfully and to the satisfaction of the Competent Authority.
- 11. CGWB has the right to forfeit the Security money, in case of non-cooperation, disobedience of the instruction, non attending of the complaint within time or due to any damage of the equipment on the part of the contractor / employees of the contractor.
- All the submitted documents must be signed & stamped by the bidder along with an undertaking that "I (name of the firm) have read the terms & Conditions of the NIQ and are acceptable to me / us". An undertaking may also be submitted with the Tender that the firm is not black listed by any Ministry / Government Office.
- 13. Incomplete or unsigned quotation / documents would be summarily rejected.
- 14. The quotation must be valid for 60 days from the date of opening.
- 15. No advance payment shall be given; however, quarterly payments would be released subject to the submission of the bill with satisfactory performance of the contractor.
- 16. CGWB, Faridabad reserves the right to cancel the entire process of awarding the AMC at any time without assigning reasons.
