Sir,

I am directed to inform that the DoPT, vide their OM No.AB-1401 7/61/2008-Estt.(RR) dated 13.10.2015 (copy enclosed), have intimated that it has been decided that before referring any proposal for framing / amendment in the Recruitment Rules of any post in Ministries / Departments and their subordinate and attached offices, the proposed amendments / revision in the Recruitment Rules would be put up on the website of respective Ministries / Departments for 30 days for inviting comments from the stakeholders. . Thereafter, taking into account the comments so received, the proposal would be sent to DoPT, UPSC and Ministry of Law for finalization. All the Ministries/Departments have been, requested to adhere to these instructions scrupulously. It has been categorically stated in the OM that proposals referred to DoPT without following the aforesaid procedure, would not be entertained.

2. In view of the above instructions CGWB is requested to upload all such proposals on their website and call for comments from stakeholders. After 30 days the concerned proposal should be forwarded to the Ministry, along with the comments received if any, for further consideration in consultation with the DoPT, UPSC and Ministry of Law. A list of pending proposals for amendment of RRs, which have been referred to the Ministry by CGWB but have not yet been finally approved by DoPT is also attached. The proposals mentioned in the list may also be uploaded on the website and comments called for. While forwarding any proposal to the Ministry it may be certified that the proposal has been uploaded on the website for a period of 30 days and the comments received, if any, may also be sent.
