Sir,

Further to this Ministry's letter No.1/1/2003-IWSU/800 dated 22<sup>nd</sup> August, 2005 on the subject mentioned above, I am directed to convey the sanction of the President to the upgradation of the Library of Central Ground Water Board from Category-II to Category-III in terms of the Ministry of Finance (Department of Expenditure O.M. No. 19(1)/1/IC/86 dated 24.7.90 and on the recommendations of the Internal Work Study Unit of the Ministry of Water Resources as accepted by JS & FA(MOWR), subject to the following conditions:-

- (i) The Library should computerize its activities and existing staff be adequately trained in computer operation.
- (ii) The organization should explore the possibility of engaging one time consultant for computerization of its library.
- (iii) Immediate review of old stock of books and non- books material should be taken up.
- (iv) The Library should develop a system by which staff at Headquarters and Field Offices and also interested parties in different Universities/State Governments and other concerned Organizations are able to make use of information about ground water which is lying in CGWB Library in the form of Books/Journals/periodicals/Reports/CD ROM/Floppies.

2. I am further directed to convey the sanction of the President to the upgradation of the post of Assistant Library and Information Officer (ALIO) from the pay scale of Rs. 6500-10500 to the post of Library and Information Officer (LIO) in the pay scale of Rs. 10000-15200 and to the placement of the present incumbent of the post of ALIO in the upgraded scale of the post of Library and Information Officer i.e. Rs. 10000-15200 with immediate effect.

3. The expenditure involved will be met out of the sanctioned budget grant of CGWB for the financial year 2005-06.

G.S.R. 99.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, and in supersession of the Central Ground Water Board, (Librarian) Recruitment Rules, 1985, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Assistant Library and Information Officer in the Central Ground Water Board, Ministry of Water Resources, namely—

1. Short title and commencement.—(1) These rules may be called the Central Ground Water Board, (Assistant Library and Information Officer) Recruitment Rules, 2003.  
(2) They shall come into force on the date of their publication in the Official Gazette.
2. Number of posts, its classification and scale of pay.—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
3. Method of recruitment, age limit, qualifications etc.—The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (14) of the said Schedule.
4. Disqualification.—No person,—  
(a) who has entered into or contracted a marriage with a person having a spouse living; or  
(b) who, having a spouse living, has entered into or contracted a marriage with any person,  
shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the person law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt such person from the operation of this rule.

5. Power to relax.— Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, for reasons to be recorded in writing, and in consultation with the Union Public Service Commission relax any provisions of these rules with respect to any class or category of persons.

6. Saving.— Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time, in this regard.

 (i) holding analogous posts on regular basis in the parent cadre/department, or with three years regular service in the posts in the pay scale of Rs. 5500-9000/- or equivalent in the parent cadre/department, or with six years regular service in the posts in the pay scale of Rs. 5000-8000/- or equivalent in the parent cadre/department; and possessing the educational qualifications and professional experience in prescribed for direct posts under Column 8.
