Nobody is present on behalf of Pancheel Greens-II,
Greater Noida West, Kbnows Nirman Ltd and Era Infra
Engineers Ltd. We issue bailable warrant against the
Managing Director/Managing Partner in the sum of Rs.
20,000/- to the satisfaction of the arresting Officer, in
exercise of our powers and in terms of the provision of
Section 19 (4) (a) of the National Green Tribunal Act,
2010 read with Order XVI Rule 10(3) and Section 151 of
Code of Civil Procedure, 1908, for securing his/her
presence on the next date of hearing.

The record reveals that there is need to clarify order dated 8th September, 2015 directing inspection of major construction projects in Delhi, Noida, Greater Noida, Gurgaon, and Faridabad for answering certain queries referred to therein. We are conscious of the fact that the teams will have to be constituted region/State wise so as to facilitate expeditious and effective inspection of major construction projects. We therefore, clarify that the inspecting teams shall be headed by Central Ground Water Authority (CGWA) who shall constitute three teams of Senior officers drawn from each of the respective authority i.e. CGWA, CPCB, DPCC, UPPCB, HPCB, Noida Authority, Greater Noida Authority, HUDA, Yamuna Expressway Development Authority, one each for every respective State as follows:

1. For the State of Delhi :Senior Officers from each

Authority -CGWA, CPCB, DPCC and DJB.

- 2. For Gurgaon and Faridabad: Senior Officers from each Authority- CGWA, CPCB, HUDA and HPCB.
- 3. For Noida, Greater Noida and Yamuna

 Expressway: Senior Officers from each AuthorityCGWA, CPCB, UPPCB, Noida Development

 Authority, Greater Noida Development Authority
 and Yamuna Expressway Development Authority.

These teams shall visit all major construction projects in their respective States indicated as aforesaid, inspect such projects, and give answers to the queries made in the order dated 8th September, 2015. The Reports of Inspection shall be published on the website of CGWA. Each noticee shall furnish copies of their respective replies to the respondent nos. 1 to 9.
