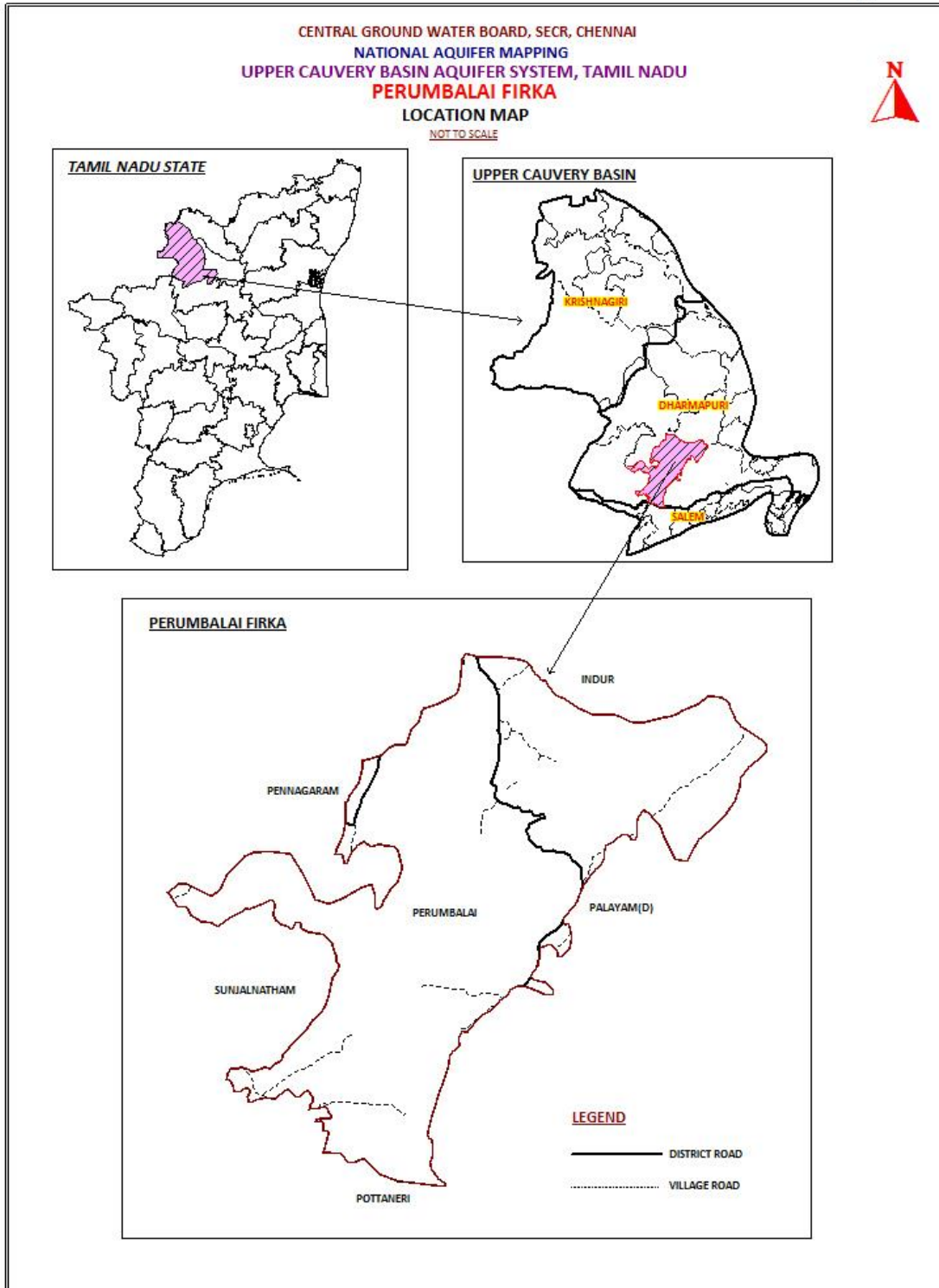
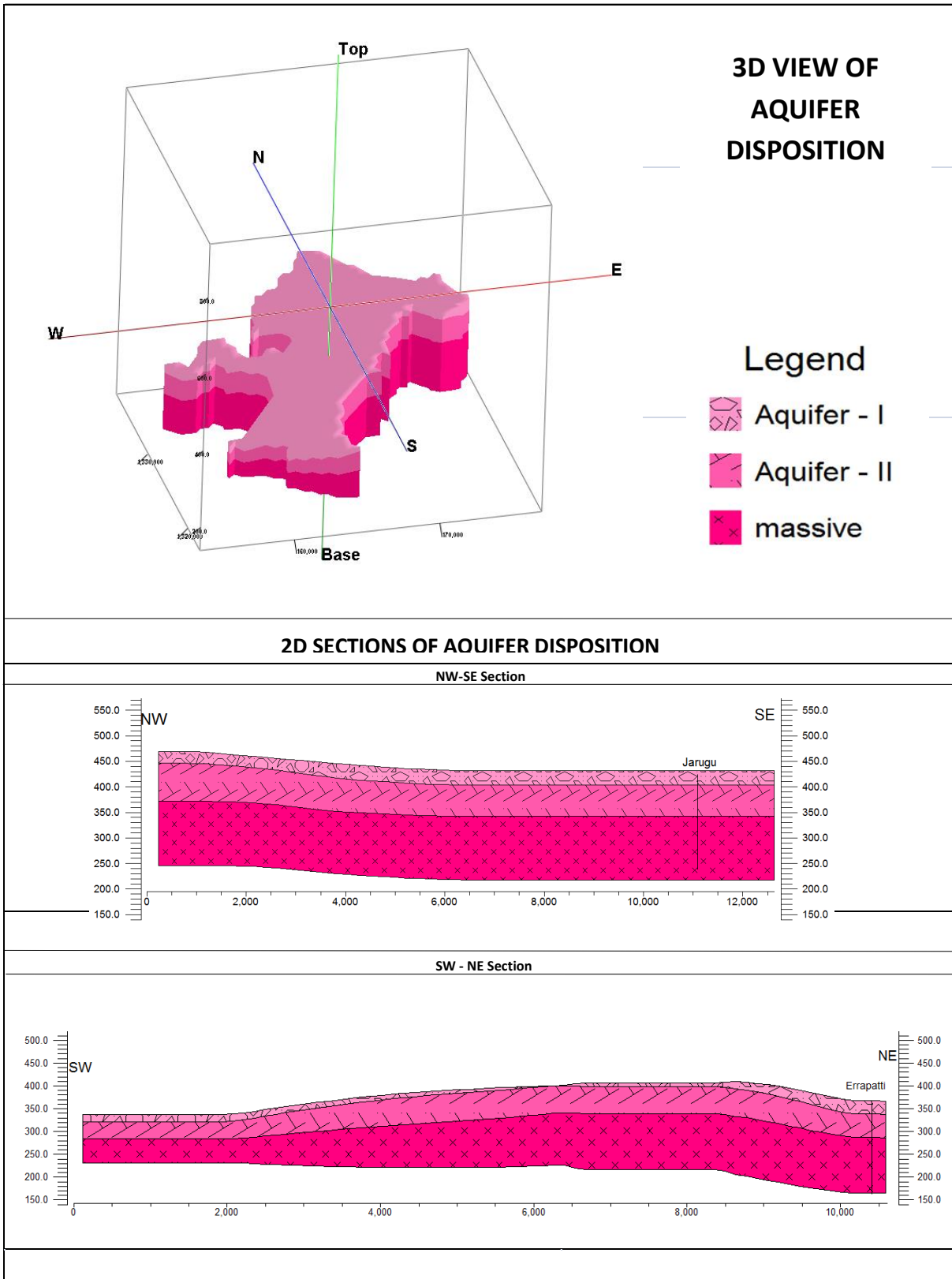


Fig:2 3D and 2D View of Aquifer Disposition, Perumbalai Firka, Dharmapuri District

Fig-3 Area suitable for GW recharge

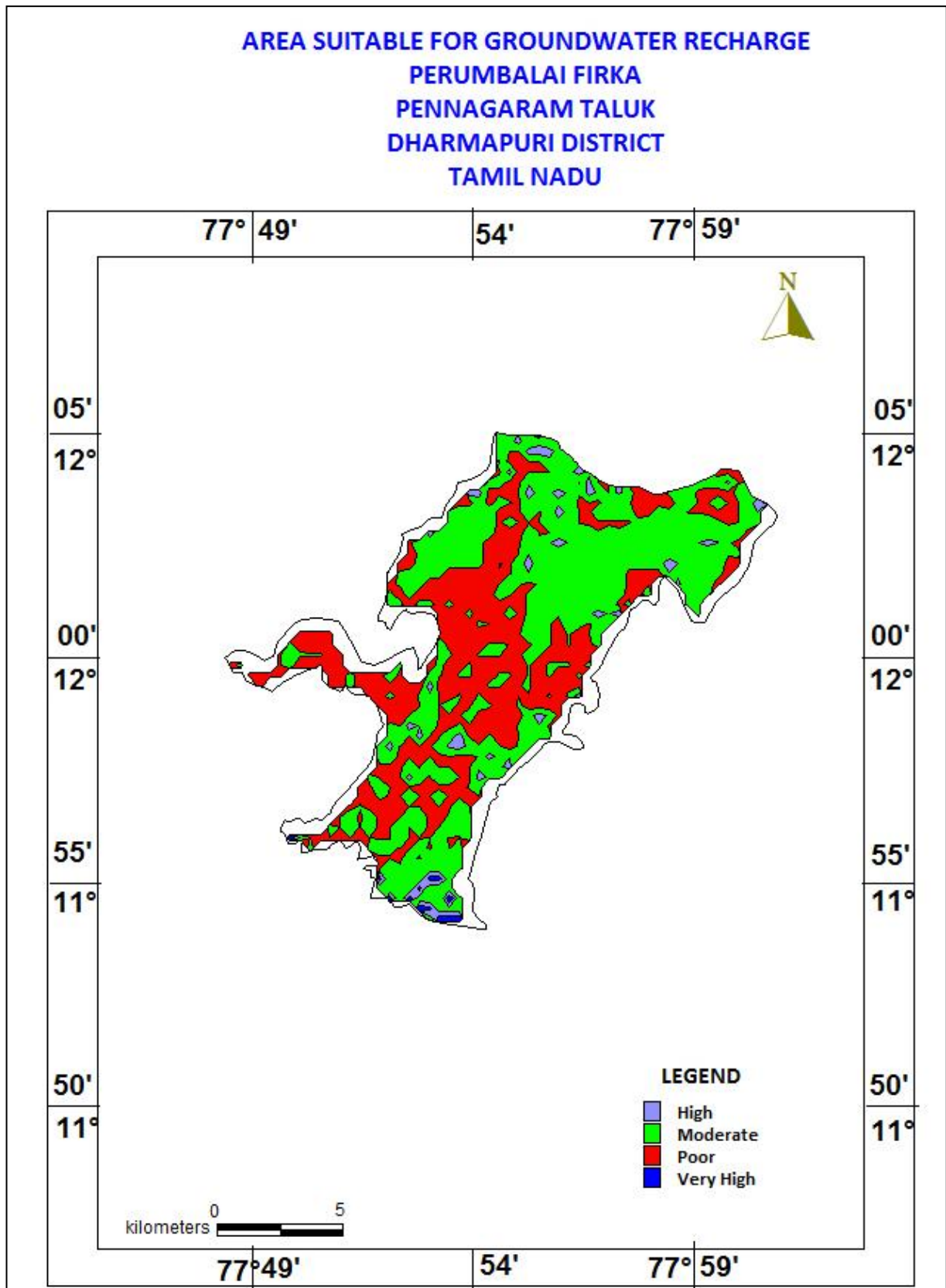


Fig-4 Location of ARS

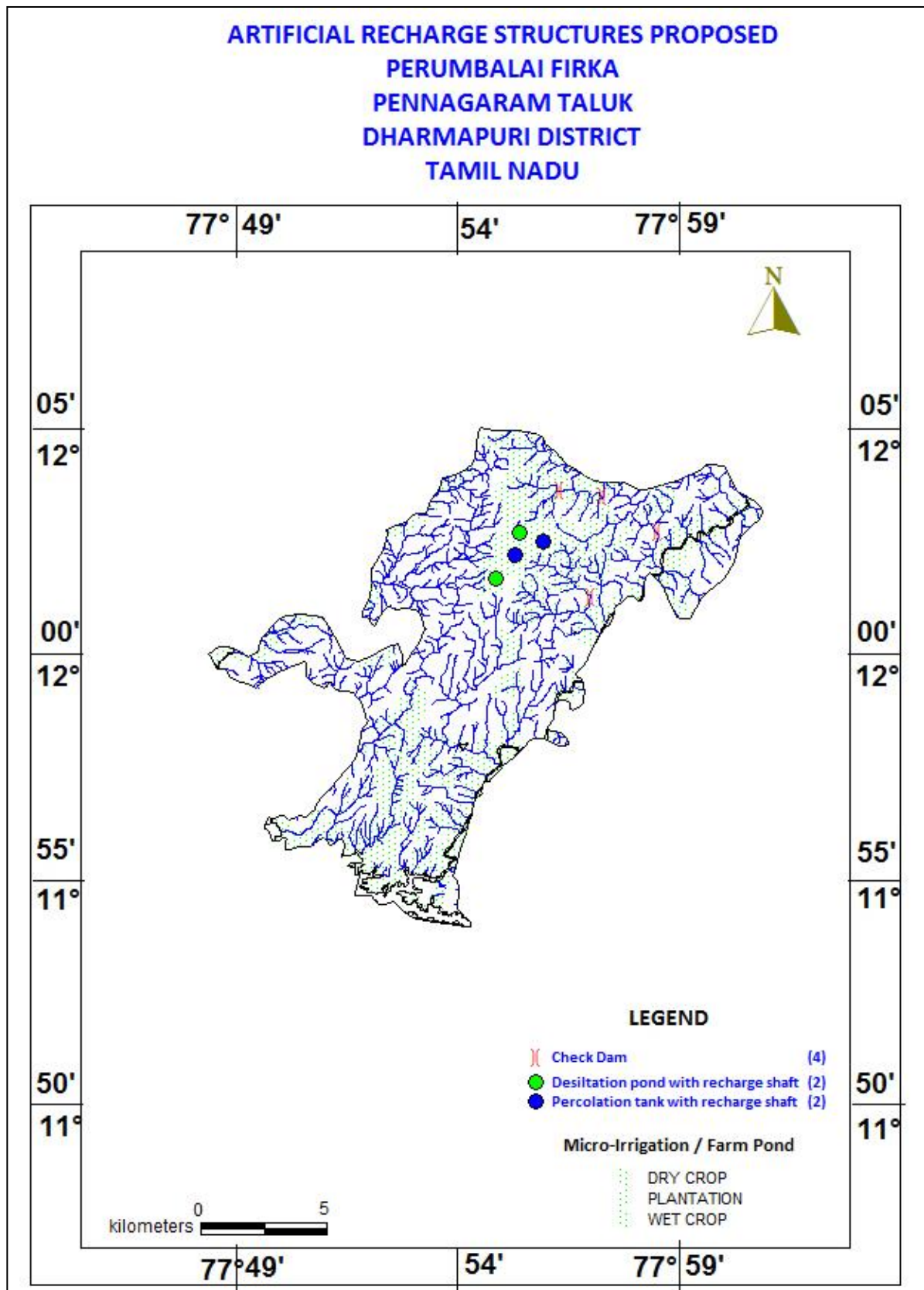
